

of its range, which covers much of S. C. Europe and the S. part of European Russia (see A. Hlavaček in *Biológia, Bratisl.*, **13** (5): 362–370 (1958)) it is found in apparently primary habitats in steppe, scrub and rocky places, whereas *L. squarrosa* is a ruderal of secondary habitats. *L. heteracantha* was considered a subspecies by Löve & Löve, and subspecific rank is certainly the most appropriate; the following new combination is required:

(192) *Amsinckia* Lehm.

The plant commonly known as *Amsinckia hispida* (Ruiz & Pavón) I. M. Johnston, a native of the Americas and a frequent casual in Europe, is the subject of some nomenclatural confusion. The basionym cited by Johnston, *Lithospermum hispidum* Ruiz & Pavón, is an illegitimate later homonym of *L. hispidum* Forskål. Johnston's name *A. hispida* I. M. Johnston is itself illegitimate, since he cited the validly published name *A. angustifolia* Lehm. as a synonym; however, the name *A. angustifolia* Lehm. is itself validly published by reference to *Lithospermum calycinum* Moris, and is in fact a superfluous substitute for this name, which is the earliest for this plant at specific rank. The new combination now required and the relevant synonymy are as follows:
